- WHEREAS, the cost of a (4) hour wedding will be (\$3,000) three thousand dollars, the cost for local residents is (\$2,500) two thousand five hundred dollars,
- WHEREAS, the cost of a (2) hour shower will be (\$1,500) one thousand five hundred dollars,
