WHEREAS, the Town of Jean Lafitte participates in the Community Rating System (CRS) and maintains a Class 7 rating resulting in 15% savings on National Flood Insurance Premiums for policyholders; and

WHEREAS, according to the 2021 Addendum to the CRS Manual, up to 100 credit points are available for a floodplain species assessment and floodplain species plan under activity 510; and

WHEREAS, the CRS issues credit to communities that identify threatened and endangered species within the community, relate the species' locations to the floodplain, review feasible conservation and recovery actions, and create a plan of action; and

WHEREAS, the Jefferson Parish floodplain species assessment which includes the Town of Jean Lafitte was completed with the assistance of FEMA as a sample for other communities across the nation and started the process of learning which species are listed or proposed for listing by the U.S. Fish & Wildlife Service or by the National Marine Fisheries Service and which associated critical habitats may be present within Jefferson Parish and the Town of Jean Lafitte; and

WHEREAS, Jefferson Parish along with the Town of Jean Lafitte further researched selected species identified in the floodplain species assessment and a more detailed plan was developed with input and assistance from subject-matter experts; and

WHEREAS, the floodplain species plan identifies actions Jefferson Parish and the Town of Jean Lafitte will pursue to support conservation and recovery of the species; and

WHEREAS, adoption by the Town of Jean Lafitte demonstrates commitment to further implement feasible actions; and
